

RECOMMENDATIONS

According to the present study the following recommendations are proposed:

A- MEDICAL:

Resuscitation and further treatment should ideally take place in any well prepared hospital.

- Only staff treating the patient should be within the immediate proximity of the patient.
- All staff with direct patient contact should follow standard precautions that the alcohol intoxicated patient may consumed adulterated alcohol with methanol.
- Gastric decontamination should be performed in early hours.
- Initial treatment of poisoned patients involves the standard ABC of resuscitation.
- Correction of fluid disturbances , hypoglycemia , metabolic acidosis should be carried immediately
- Train the doctors and other health care staff on treatment
- Continuous monitoring is required for developed complications especially in methanol intoxication . Careful observation probably saves many lives.
- Specific antidote treatment should be instituted based on the clinical picture and not on test results.
- The necessity of the presence of equipment that measure alcohol level.
